# INTERNATIONAL CONGRESS ATTENDEES: ENTERING RUSSIA

## Documents for crossing the border

To avoid encountering any problems when crossing the border, all foreign participants arriving from abroad are required to bring the following documents with them:

### If you **require a visa** to enter Russia

- Invitation for foreign arrivals  
**! Please note that this is not an invitation to the Congress, but a separate document from the Congress organizers.**
- Valid foreign passport and visa
- Medical insurance policy that is valid in Russia

### If you **do not require a visa** to enter Russia

- Valid foreign passport
- Medical insurance policy that is valid in Russia

Participants **are not required** to present a PCR test result for entry to Russia or undergo self-isolation after arrival in St. Petersburg.

## Obtaining a visa

Upon presenting all the required documents, participants will be able to receive a same-day, short-term, single-use entry visa into the Russian Federation for the period **from 17 May to 3 June 2023**. In order to apply for an entry visa, the invited individual should visit their local consular office of the Russian Federation. The locations of your nearest Russian consular office can be found on the [website of the Ministry of Foreign Affairs of the Russian Federation](#).

**Visa = invitation for foreign arrivals + list of documents**

**An invitation for attendees from foreign countries** can be generated in the [Roscongress personal account](#) ('My events – NIEC – Event dashboard – Visa support').

Your personal information will be automatically uploaded from the Roscongress personal account to the document. You can manually add the city and country where you will be applying for your visa.

If you have found any errors in your personal data in the application for participation, you can contact a Roscongress Foundation specialist to make changes to the personal data.

## Visa-free regime

Citizens of some states can enter the Russian Federation without a visa for 30 to 90 days (apart from trips for work or commercial activities).

To cross the border, attendees need the following documents:

- Valid foreign passport
- Medical insurance policy that is valid in Russia

## ARRIVAL IN ST. PETERSBURG

### Arrival by air. Pulkovo Airport

Pulkovo Airport (LED) is St. Petersburg's only airport that serves scheduled domestic and international flights. The journey from the airport to the Congress venue takes about 60 minutes, depending on the traffic.

### Arrival by rail

#### MOSCOW – ST. PETERSBURG

Sapsan high-speed trains depart from Leningradsky and Kursky Rail Terminals in Moscow, and arrive at Moskovsky Rail Terminal in St. Petersburg. Up to 17 trains run along the route daily, with the journey time ranging from 3.5 to 4 hours.

## Currency and bank card transactions

### CURRENCY EXCHANGE

Please note the following currency exchange restrictions in the Russian Federation:

- Only USD and EUR cash can be freely exchanged for RUB cash
- You must present your ID (passport) for transactions over RUB 40.000
- There is NO exchanging non-cash currency for RUB cash using Mastercard or Visa bank cards issued outside of Russia. It is also not possible to withdraw RUB cash from these cards

### BANK CARDS

We do **recommend having cash with you** for the entire duration of the Congress due to restricted use of foreign bank cards in Russia.


The use of MIR and UnionPay cards in Russia is not restricted in any currency. We do recommend Nevsky International Ecological Congress participants to get a new card/bring an existing card of these systems, if possible.

*Please note that UnionPay has started its operations in Russia relatively recently. Therefore, cards of this payment system may occasionally malfunction.*

## Hotel accommodation

The Nevsky International Ecological Congress will take place in the Tavrichesky Palace that is the [headquarters of the Interparliamentary Assembly of the CIS Member Nations](#). The Tavrichesky Palace offers an ideal blend of an advanced technology platform for Congress participants to work at and a splendid historic interior. The palace features all the rooms and halls required for holding major international symposia, conferences, Congresses and business meetings.

The Tavrichesky Palace is located in St. Petersburg's historic centre. The journey from the airport to the Congress venue takes about 60 minutes, depending on the traffic.

In order to avoid any inconvenience when accessing the venue, participants are advised to leave any [items prohibited at the Congress venue](#) at their accommodation or in their vehicle.

## ACCESS TO THE CONGRESS VENUE

### Accreditation badge

An accreditation badge is required to enter the Congress venue and a number of cultural programme events.

**The badge is personalized and may not be transferred to third parties.** Participants must have their badge and identity document (passport) with them at all times while at the Congress venue.

If the accreditation badge is lost or damaged, please go to the Help Desk or any accreditation stand.

### What should be checked before collecting the badge?

Before obtaining a badge, please make sure that the following conditions have been observed:



\* Colour photo against a light background, photo size 480x640 pixels, file format – jpg or jpeg, full-face photo with no headgear, with the face taking up at least 70% of the photo.

If information contained in the participant's ID has changed in the time since a participation application was submitted, the participant's [Roscongress personal account](#) must be updated accordingly. If changes need to be made to uneditable fields, please contact your personal manager at the Roscongress Foundation.

In order to expedite the procedure for issuing a badge, please **upload a scan of the passport** (pages containing photo and ID info) in the 'My Events – Nevsky International Ecological Congress – Event dashboard – Personal information' section of the [Roscongress personal account](#).

Please ensure that scans are legible and contain all the information entered during registration, including passport number and serial number (if applicable), passport issuing authority, date of issue, and photograph.

## **How to collect your badge?**

PCR testing is not required to get a badge. You can collect your accreditation badge first, then take the PCR test, or vice versa.

### **COLLECTING A BADGE IN PERSON**

Participant accreditation badges may be collected **in person** by presenting:

- The identity document that is listed in the [Roscongress personal account](#)
- Original of personal data consent form\*

### **COLLECTING A BADGE BY AUTHORIZED THIRD PARTY**

If a participant's badge is collected **by a third party** using a power of attorney, the authorized person must present the following:

- The authorized third party's passport
- An original standard power of attorney\*
- A list of participants
- Copies of the passports of all participants to be accredited
- Originals of personal data consent forms\*

\*A power of attorney form and a personal data consent form can be downloaded from the '[Badge collection](#)' section of the Congress website.



Before issuing a badge, an accreditation point attendant will make sure that the data specified in the [Roscongress personal account](#) corresponds to the ID document. In the event of any discrepancies, it will not be possible to issue a badge the same day.

## PCR testing for badge activation

### WHEN TO GET TESTED?

All Congress participants, media representatives and staff who will be present at events must take a PCR test for COVID-19.

**PCR test to access the Congress venue must be taken no earlier than 07:00 on 24 May (GMT+3) and no later than 24 hours before visiting the Congress venue.**

Results will be provided within 24 hours.

The badge will remain active from the moment a negative result has been uploaded to the Congress information system until the end of NIEC. One PCR test is enough to attend all NIEC events.

### WHERE TO GET TESTED?

Testing will be carried out at the Congress's **dedicated** testing centres, which are provided by Rospotrebnadzor in Moscow and St. Petersburg. The results will be uploaded to the Congress information system automatically.

**The results of tests taken at other laboratories will NOT be accepted for access to the venue.**

## DATA REQUIRED FOR TESTING

### 1. Information about your immunity to COVID-19

It is necessary to fill in all the required fields related to COVID-19 immunity in the [Roscongress personal account](#):

- Information about COVID-19 vaccination status
- Information about previous coronavirus infection (COVID-19) status
- Information about the presence or absence of COVID-19 antibodies
- Information about permanent residence and temporary address in St. Petersburg during the Congress

### 2. Congress participant ID

The ID is a participant's identification number in the Roscongress personal account. You can view your ID:

- On the badge (if it has already been received)
- In the 'Personal data' section of the [Roscongress personal account](#)
- In the 'My events – NIEC – Event dashboard' section of the [Roscongress personal account](#)

**If a test is not associated with a participant ID, it will not be possible to send the test results to the Accreditation Centre in order to activate the badge to attend the event.**

### **3. Medical treatment consent form**

For participants planning to take a PCR test in Moscow, you must print, fill in and sign a medical treatment consent form before visiting the testing centre and bring it with you. Medical treatment consent form can be downloaded in the ['PCR testing'](#) section on the Congress website.

## **BOOKING A TEST**

**PCR testing at dedicated Congress testing centres is strictly by appointment only.**  
Please arrive at the time of your booking.

In the [Roscongress personal account](#), go to the 'My events' section and choose 'NIEC', then open the 'Event dashboard – COVID-19' tab. In the 'COVID-19 – PCR testing centre and time slot selection' section, choose the most convenient testing centre from the list and select a time slot.

Please note: in order to book a PCR testing you must follow the two terms:

- All the required fields of the questionnaire in the 'Data on immunity to COVID-19' section are filled in the [Roscongress personal account](#).
- The contact phone number and contact email are indicated in the questionnaire of the 'COVID 19' section. It is not necessary to authorize the phone number.

## **TEST RESULTS**

Lab results will be provided within 24 hours.

The plenary session and certain business programme events will feature simultaneous interpreting between Russian and English.

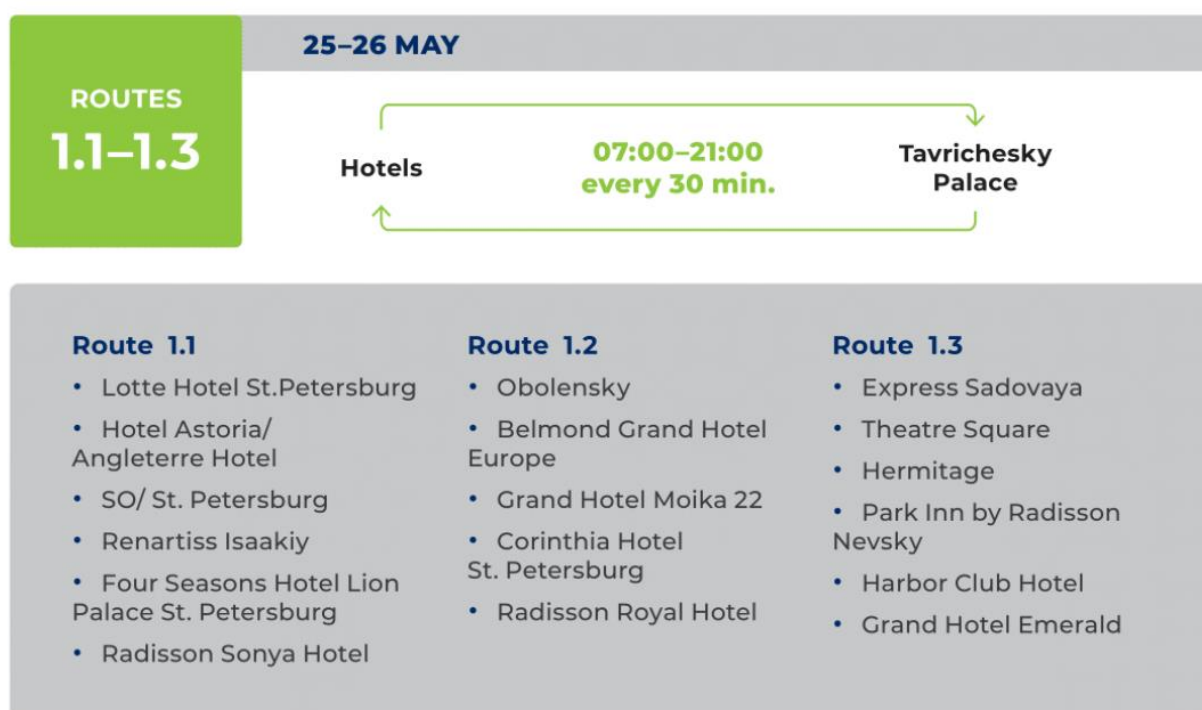

## Weather in St. Petersburg

St. Petersburg has a humid coastal climate. The average temperature at the end of May is +16...+20 °C. Due to the city's geographic position and its proximity to the Baltic Sea an extreme change of weather is possible. We recommend Congress guests to bring warm clothing and an umbrella with them.

A slew of drawbridges is an integral part of the main waterways of St. Petersburg. Therefore, when moving around the city center at night, you should take into account the actions of sea and river navigation and check your route with the schedule of the bridges.

## Emergency procedures

The Congress venue is furnished with modern safety equipment, including video surveillance and fire extinguishing systems.
